I agree to indemnify the AHBA, it's officers, directors, agents and members for any loss, cost or expense including attorneys' fees and costs, to which the AHBA, it's officers, directors, agents or members might be subject as a result of any claim, suite, loss, or damage caused in any way by any act or negligence on my part or on the part of any dog or dogs I have entered in or brought to this event. I acknowledge that while the AHBA may provide sanctioning for this event with regard to the issuing of titles, it does not have and does not exercise control over the conduct of the event or those present.
