IMPORTANT INFORMATION

AHBA RULE: Registration/tracking number is required for ALL dogs. This can be from any canine organization, or you can contact AHBA for a free number.

TRIAL RULES: Trials are held in accordance with current AHBA rules posted at www.ahba-herding.org.

FARM RULES:

- All dogs must have current vaccination for rabies and other communicable diseases as recommended by your veterinarian, and should be parasite free.
- **PICK UP AFTER YOUR DOGS** ... poop bags are available around the farm.
- All dogs must be on a leash or crated when not working.
- **NO FLEXI-TYPE LEASHES ARE ALLOWED ON THE FARM.** Please keep your dogs on a short leash at all times.
- Water pools are provided, but there is little or no shade, so plan accordingly.
- Handlers and spectators should keep their dogs at least 15 feet back from the fenced arena while a dog is working.

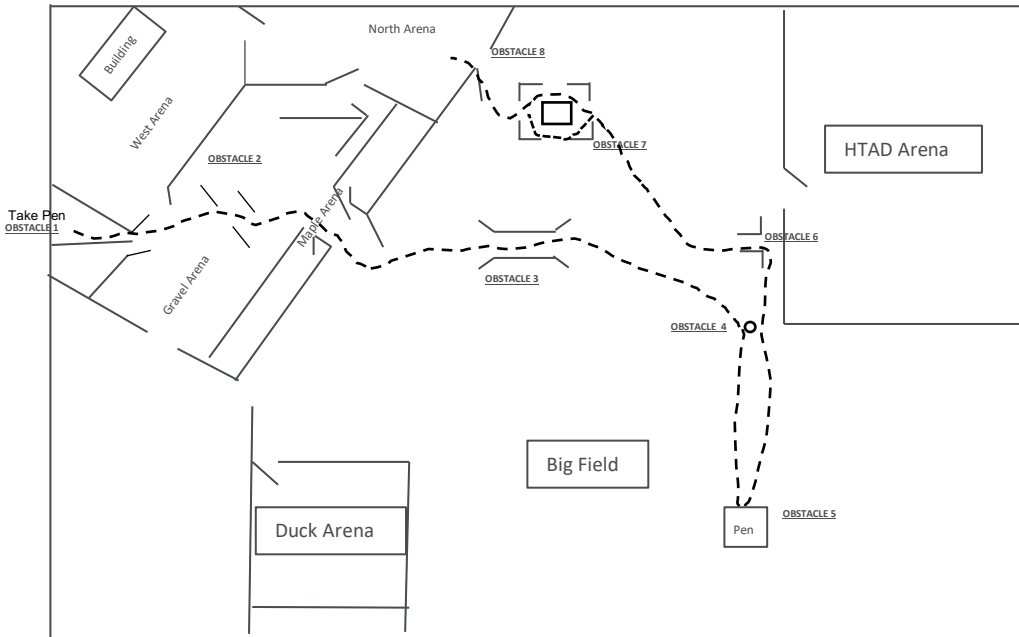

1	Obstacle 1 - Take Pen: Level 3 stands at gate; 2 can stand between gate and sheep; 1 may go in and help dog.	10
2	Obstacle 2 – Panels: Sheep go north through panels, and must exit right (east) before next panel. Minus 1 point for each sheep that goes left (west). All levels handler stands between take pen and panels	10
3	Obstacle 3 - Bridge: 3 stays at entrance of bridge; 2 may walk anywhere around bridge; 1 may walk over bridge ahead of sheep	5/10
4	Obstacle 4 - Drive/wear to tree: Dog must hold sheep at tree. Level 3 must stay at bridge until sheep arrive at tree; 2 may walk behind go; 1 may walk in front of sheep while dog wears sheep to tree.	10
5	Obstacle 5 - Sort at free standing pen: Level 3 must have 3 sheep in and 3 out; 2 must have 1-5 sheep in (but not all sheep); 1 all sheep in pen.	10/15
6	Obstacle 6 - Fence chute: Sheep must enter chute from south then exit west. Point deducted for each sheep that exits to north. All levels can move anywhere around obstacle. No one can enter obstacle. [TIEBREAKER #1]	20
7	Obstacle 7 - Double box: Dog takes sheep from east to west to opening directly across. One point deducted for any sheep leaving obstacle from any other opening. All levels can move anywhere around obstacle, but may not go inside. [TIEBREAKER #2]	20
8	Obstacle 8 - Repen sheep in North arena: Dog must hold sheep off gate while handler opens the gate.	5

Entry Agreement and Indemnity

The person who signs this Entry represents that she/he is authorized to enter into this Agreement and Indemnity on behalf of both the Handler and Owner of the entered dog in consideration of acceptance of this entry.

Handler and Owner whether or not members of American Herding Breed Association ("AHBA") agrees to abide by the rules and regulations of AHBA and all other rules and/or regulations shown in the premium list for this event.

Handler and Owner certify that the entered dog is not a hazard to persons, dogs or property. In the event the entered dog injures any livestock, the owner will pay for veterinarian services. If the injury is severe, the owner will pay the market value or value stated in the premium list of the stock injured.

Handler and Owner acknowledge that herding events are inherently dangerous and have risks of injury to persons. Handler and Owner agree to assume the risk of any harm arising from the hazards associated with the herding event which include but are not limited to, parking areas, ground conditions, animals, stock used in the herding event, and other dogs.

Handler and Owner hereby release AHBA, its officers, directors agents and members, including Shannon Wolfe, Magic's Legacy (its officers, agents and directors) and the owners of the site of the event, from any and all liability for any injury, loss or damage, of whatever kind or nature, whether to person or property which occurs directly or indirectly or associated with the herding event.

Handler and Owner agrees to indemnify and hold harmless AHBA, its officers, directors agents and members, including Shannon Wolfe, Magic's Legacy (its officers, agents and directors) and the owners of the site of the event, from any and all claims, loss or expense, including attorney's fees, arising out of any injury, loss or damage, of whatever kind or nature, whether to person or property which occurs directly or indirectly or associated with acts or failure to act of Handler or Owner, or any of the dogs entered in the herding event or brought to the site of the herding event.
