Time and points trial entries will be very limited . Clinic participants will receive first chance at entry.

- Tests shall be run under AHBA rules and regulations. FMI: www.AHBA-herding.com
- Use one entry form for each dog entered.
- Each individual is responsible for any damage caused by him or herself, his or her dog(s), and any spectator who is accompanying dog. Ewe replacement costs are \$350 should your dog injure or kill one of the flock, These sheep are worked by dogs on a regular basis. Cattle replacement costs \$850 and ducks \$40.
- AHBA, Tim and Tommye Ann Allison and Cathy Hartley assume no responsibility for any accident or injury.
- All dogs must be brought to test ring on a leash. We will provide a longer line if warranted.

Test or trial runs must be paid in full. Daily working spots for \$140 per day on a first come first served basis if clinic does not fill. Limited to 12 working spots.
