- Each individual is responsible for any damage caused by himself, his family or his dog while in the trial arena or on the trial grounds. Livestock replacement costs are as follows: Ducks- \$45.00 Geese - \$75.00. AHBA, Back Porch Herding, John and Sue Amsden and all trial workers assume no responsibility for any accident or injury.
- Bitches in season will run last. They should be crated away from trial arenas when not competing.
- All dogs must be on leash when not competing.
- Entry confirmation will be sent by email; please be sure to include your email address.
- Trial committee will draw run order prior to the trial.
- Entry fees will only be refunded if request is received by pre-entry closing date (November 14, 2022).

DIRECTIONS TO TRIAL SITE

From Highway 421, Take Exit 190, turn right on NC 62 South – travel 3.2 miles. Take a left turn on Racine rd. at traffic light – travel 2.2 miles. Take a right on Red Lane rd. (Hit the brakes when you see Ezra rd. on the right as Red Lane is almost immediately after Ezra). We are the next to last place on the left.

From I-73 Take exit 89 –turn left (coming from the north or right coming from the South) onto NC 62 North – travel 3 miles. Turn right on Hunt rd. (becomes Whitt Hunt Rd) – travel 2 miles. Take a right on Racine rd. – travel 1 mile. Take a right on Red Lane rd. (Hit the brakes when you see Ezra rd. on the right as Red Lane is almost immediately after Ezra). We are the next to last place on the left.

Using a GPS works fine.

All dogs nine months of age or older are eligible to participate in Herding Trials and JHD. Dogs classified as Herding Dogs in AHBA are eligible for HERDING TEST (HCT) and may participate at six months of age or older. No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any Test/Trial. Bitches in season shall run last.

IMPORTANT. READ THIS BEFORE SIGNING.

In consideration for participation in an event sanctioned by the American Herding Breed Association (AHBA), I agree to assume all responsibility for any claim, loss or damage, of whatever kind or nature, whether to person or property, which may be caused at or near this event, either directly or indirectly, by me or the dog or dogs I have entered in or brought to this event.
