PRE -ENTRIES OPEN MAY 18

Pre-entries postmarked before MAY 18, 2023 will not be accepted. Entries must have clearly visible USPS postmark with the date. Pre-entries must be postmarked on/before close date of JUNE 14 , 2023. No metered mail, telephone, facsimile, email or incomplete entries will be accepted. The entry limit per judge (40/day) will be accepted in postmark order. If a class is full the dog will be put on a waiting list in order of receipt. Day of Trial Entries (if available) accepted up to 30 minutes before trial start

This trial shall be run under all AHBA rules and regulations. FMI: www.ahba-herding.org

- Ⓢ Each individual is responsible for any damage caused by himself, his family or his dog while in the trial arena or on the trial grounds.
- Ⓢ Livestock replacement costs are as follows: Ducks - \$20.00, sheep - \$300.00
- AHBA, Florida Working Dog Club Inc, Diane Menard and all trial workers assume no responsibility for any accident or injury.
- Ⓢ Bitches in season will run last. They should be crated away from trial arenas when not competing.
- Ⓢ All dogs must be on leash when not competing.
- Ⓢ Entry confirmation will be sent by email; please be sure to include your email address.
- Ⓢ Trial committee will draw run order prior to the trial.
- Ⓢ Entry fees will only be refunded if request is received on or before pre-entry closing date (June 14).

ELIGIBILITY

All dogs nine months of age or older are eligible to participate in Herding Trials and JHD. No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any Test/Trial. Bitches in season shall run last.

ENTRIES & FEES :

Ⓢ In the event that any dog is deemed absent prior to JUNE 14,2023, its' trial slot(s) will be filled from the waiting list and any entry fee(s) will be refunded to the original entrant only, unless the original entrant provides a substitute dog. Substitutions will be allowed if the substitute dog is owned by the original entrant.

Ⓢ Entry fees will not be refunded after JUNE 14, 2023 in the event a dog is absent, disqualified by a judge, or barred from competition by the trial committee. Entry fees will be refunded if excused in writing by a veterinarian.

Ⓢ Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire and/or dangerous weather conditions, acts of God, public emergencies, acts of public enemy, strikes or other causes beyond the control of FLORIDA WORKING DOG CLUB INC.

Ⓢ Selling runs is not permitted unless the trial is full. All offers to buy or sell runs must be submitted to the show secretary

ⓈBLACK BIRCH FARM SOUTH will deposit entry fees in our bank account on or about JUNE 14, 2023. Any checks returned for insufficient funds will be considered a void entry. There is a \$50 service charge for returned checks. If entries are resubmitted, payment must be in the form of cash, Money Order or Cashiers' Check.
