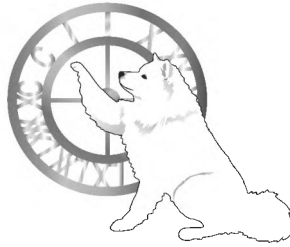

ALL EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS OR MONEY ORDERS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

RETURNED CHECKS do not constitute a valid entry fee. If a check is returned, fees must be paid in guaranteed funds; checks will not be accepted as a replacement. The Secretary will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in being placed on a cash only basis. Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or barred from competition by action of Show Committee.

The Show giving Club, the Show Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without signatures on forms sent by mail.

Changes, additions or corrections to entry forms must be received in writing or email prior to close of entries. Refunds of \$5.00 or less will not be issued due to cost of processing. Entries sent via Express Mail must have the signature waived.
