GOOSE PALOOZA RANCH TRIAL

1. Gather in 82 x 100 (Poultry trial arena) Go thru Gate A into 82 x 40 pen
2. Go thru free-standing obstacle 1 then through gate B onto road
3. Take geese down road along creek and then over bridge, turn left onto road
4. Depending on level, drive fetch thru free-standing obstacle 2
5. Return to poultry trial arena (82x100) Sort 5 geese into side gate. Take remaining 10 to exhaust pen.
6. Take pen: Collect the 5 geese in side pen. Return the 5 geese to exhaust pen. Time stops when exhaust gate is closed.

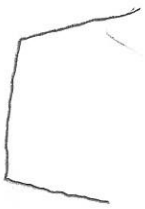
