Bitches in season will run last. They should be crated away from trial arenas when not competing. All dogs must be on leash when not competing. Entry confirmation will be sent by email; please be sure to include your email address. Trial committee will draw run order prior to the trial. Entry fees will only be refunded if request is received before pre-entry closing date. AWARDS (including but not limited to) flat ribbons for all qualifying runs, flat ribbons for 1st thru 3rd placements, HIT rosette and Reserve HIT Rosette (both trials)

ELIGIBILITY All dogs nine months of age or older are eligible to participate in Herding Trials and JHD. Dogs classified as Herding Dogs in AHBA are eligible for HERDING TEST (HCT) and may participate at six months of age or older. No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any Test/Trial. Bitches in season shall run last.
