**Directions:**

- From Hwy. 16, Exit for Purdy/Key Center/Shelton, Hwy 302 W
- Travel into Purdy, turn west at the light onto Hwy 302 W.
- Cross the Wauna Bridge, travel 5.1 miles
- Turn RIGHT onto Hwy 302 W, Elgin Clifton Rd NW, toward Shelton/Allyn
- Travel 1.2 miles, turn RIGHT onto 150<sup>th</sup>
- Travel 0.1 miles (end of chain link fence) turn LEFT onto 1<sup>st</sup> road, Rocky Creek Conservation Area.
- Follow road approximately 0.8 mile through park, until you see PackLeader's green farm gate.
- House is a grey two-story. Follow the road past the house and toward the back of the property.
