***Judges are allowed to run their dogs under the other judge and her stock assignment for the day. Judges shall not be eligible for placements or HIT but may take passes/scores for titles.***

Use official AHBA entry form.

Each individual is responsible for any damage caused by himself, his family or his dog while in the trial arena or on the trial grounds. Livestock replacement costs are as follows: Ducks - \$50, Sheep - \$350.00.

Bitches in season will run last in test runs. They should be crated away from trial arenas when not competing.

All dogs must be on leash when not competing.

Trial committee will determine run order prior to the trial.

Entry fees will only be refunded if request is received before pre-entry closing date.
