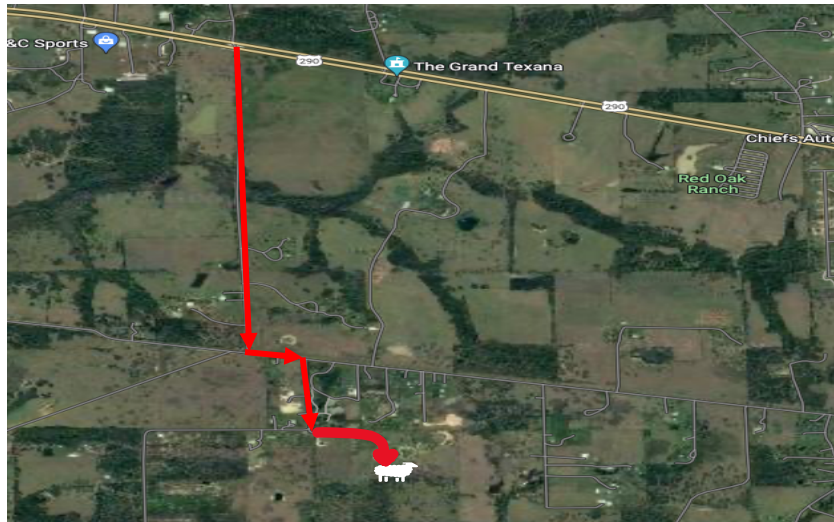

CRATING: The Roux Crew is a private farm and no early set up allowed. Most of us crate out of our vehicles.

BITCHES IN SEASON POLICY: Bitches in season will be allowed to compete but will be placed at the end of the test or trial run.

Please notify the Test/Trial Secretary the morning of the trial before judging is to begin if your bitch is in season.

ALL DOGS PRESENT MUST BE HELD ON LEASH or otherwise restricted except when in the exercise ring. Under NO circumstances will dogs be allowed to disturb the resting stock or interfere outside the arena with another dog's performance in the arena. Exhibitors are expected to maintain the premises in a clean and tidy condition. **Please pick up after your dog and yourselves so we can continue to hold trials at the facility.**

ATTENTION:

Handler's meeting will be held at 8:30 AM. Please attend as we will discuss Ranch and HTD courses. We will walk through both Ranch Courses.

A reminder that this is a private farm.

There are no special facilities for the handicapped.

The ground may have irregularities that can cause tripping.

There are guardian dogs working in other areas of the farm.

There is a deep pond that is available for swimming dogs, if you choose to do so, it is at your own risk.

If you have special needs, please feel free to contact Trial and Test Secretary Jay Kiper and we will try and work with you.

Owners should use one consistent name when entering a dog at AHBA events. For dogs which are registered, the dog's registration number must be included. If a dog is registered in more than one registry, the owner must choose which registry number to use and use it consistently for AHBA events.

For dogs which have no registration number, the owner should obtain and fill out an AHBA Request for Tracking Number form and send it to the address listed on the form (page 5).

Ranch Course Trial 1

Ranch Course 1 on April 18, 2025

HRDI - All gates are to be returned to original position after passing through.

1. Using any combination of pens and paddocks, sort out 10 head of fresh sheep from the 50 X 50 paddock. Move fresh sheep to A paddock (100 X 100). Place used sheep that are in alleyway B with remaining sheep in the 50 X 50 paddock.
2. Open 4' gate at NW corner of A paddock. Fetch or drive sheep down driveway to Parking area C.
3. Place the sheep in the stock trailer. Remove sheep.
4. Open gate to Idaho pasture, move sheep through gate. Continue fetching or driving, moving sheep to cone D. Place dog at 125' cone, handler may walk to within 15 feet of the sheep. Send dog on outrun and fetch or drive sheep to the top of Idaho pasture, gate E.
5. Open gate, move sheep back to driveway. Fetch or drive sheep to North end of alleyway B. Sheep must pass between cones on driveway ~ 200' from parking area C.
6. Pen sheep.

HRDII - All gates are to be returned to original position after passing through.

1. Using any combination of pens and paddocks, sort out 10 head of fresh sheep from the 50 X 50 paddock. Move fresh sheep to A paddock (100 X 100). Place used sheep that are in alleyway B with remaining sheep in the 50 X 50 paddock.
2. Open 4' gate at NW corner of A paddock. Fetch or drive sheep down driveway to Parking area C.
3. Place the sheep in the stock trailer. Remove sheep.
4. Open gate to Idaho pasture, move sheep through gate. Drive sheep to cone D. Place dog at gate by parking area C, handler may walk to within 15 feet of the sheep. Send dog on outrun and fetch or drive sheep to the top of Idaho pasture, gate E.
5. Open gate, move sheep back to driveway. Fetch or drive sheep to North end of alleyway B. Sheep must pass between cones on driveway ~ 200' from parking area C.
6. Pen sheep.

HRDIII - All gates are to be returned to original position after passing through.

1. Using any combination of pens and paddocks, sort out 10 head of fresh sheep from the 50 X 50 paddock. Move fresh sheep to A paddock (100 X 100). Place used sheep that are in alleyway B with remaining sheep in the 50 X 50 paddock. Open 4' gate at NW corner of A paddock, get in cart and fetch or drive sheep to Parking area C. Leave cart.
2. Place the sheep in the stock trailer. Remove sheep.
3. Open gate to Idaho pasture, move sheep through gate. Continue driving, moving sheep to cone D. Place dog at gate by parking area C, handler must stay with dog. Send dog on outrun and fetch sheep back to gate E.
4. Open gate, move sheep back to driveway. Get in cart and fetch or drive sheep to North end of alleyway B. Sheep must pass between cones on driveway ~ 200' from parking area C.
5. Pen sheep.

Time allowed: 20 Minutes. Tie breaker #1 Outrun/Lift. Tie breaker #2 Time



Ranch Course Trial 2

Ranch Course 2 on April 18, 2025

HRDI

1. Place dog at panels in B course field, handler may walk to within 14 feet of the sheep. Time starts when handler sends dog. Outrun, lift and fetch, walking to handler's post.
2. Turn at the post and handler may either fetch or drive sheep to the gate A.
3. Gate sort 4 sheep into A course. Drive or fetch remaining 4 sheep to the free-standing pen. Pen sheep.
4. Remove sheep from pen, fetch or drive to the A gate. Regroup sheep in A course, fetch or drive to the holding and sorting pens B. Put sheep in alleyway C.
5. Using any combination of pens and paddocks, sort out 8 head of fresh sheep. Move fresh sheep to A course. Place used sheep in alleyway with remaining sheep and return them to the paddock D.
6. Group sheep in A course; move them through the gate A into B course field. Leave sheep at gate, call off dog, and walk to free standing pen. Send dog to gather sheep, handler may move to within 14' of sheep. Fetch or drive to 4' gate E and pick up scoop of feed. Fetch or drive sheep to Cone F. Place dog on stay, scatter feed, call off dog and leave sheep.
7. Exit through 4' gate E, replacing scoop in bucket. Time ends when handler and dog pass the drive panels.

HRDII

1. Place dog at post in B course field, handler may walk to panels. Time starts when handler sends dog. Outrun, lift and fetch, walking to handler's post.
2. Turn at the post and dog must drive sheep to the gate A. Handler may stay within 14' of dog.
3. Gate sort 4 sheep into A course. Drive or fetch remaining 4 sheep to the free-standing pen. Pen sheep.
4. Remove sheep from pen, drive to the A gate. Handler may stay within 14' of dog. Regroup sheep in A course, fetch or drive to the holding and sorting pens B. Put sheep in alleyway C.
5. Using any combination of pens and paddocks, sort out 8 head of fresh sheep. Move fresh sheep to A course. Place used sheep in alleyway with remaining sheep and return them to the paddock D.
6. Group sheep in A course; move them through the gate A into B course field. Leave sheep at gate, call off dog, and walk to 4' gate E and pick up scoop of feed. Move to Drive panels G with dog. Send dog to gather sheep, handler may move halfway if necessary. Fetch or drive sheep to Cone F. Place dog on stay, scatter feed, call off dog and leave sheep.
7. Exit through 4' gate E, replacing scoop in bucket. Time ends when handler and dog pass the drive panels.

HRDIII

1. Place dog at post in B course field, handler must stay with dog. Time starts when handler sends dog. Outrun, lift and fetch to handler's post.
2. Turn at the post and handler must remain at post while dog drives sheep to the gate A.
3. Gate sort 4 sheep into A course. Drive or fetch remaining 4 sheep to the free-standing pen. Pen sheep.
4. Remove sheep from pen, drive to the A gate. Handler may stay within 24' of dog. Regroup sheep in A course, fetch or drive to the holding and sorting pens B. Put sheep in alleyway C.
5. Using any combination of pens and paddocks, sort out 8 head of fresh sheep. Move fresh sheep to A course. Place used sheep in alleyway with remaining sheep and return them to the paddock D.

6. Group sheep in A course; move them through the gate A into B course field. Leave sheep at gate with dog, walk to 4' gate E and pick up scoop of feed. Call dog and walk to Cone F. Scatter feed, send dog to gather sheep, fetch through Drive Panels G to Cone F. Leave sheep.
7. Exit through 4' gate E, replacing scoop in bucket. Time ends when handler and dog pass the drive panels.

Time allowed: 20 Minutes. Tie breaker #1 Outrun/Lift. Tie breaker #2 Time
