AGREEMENT

In consideration for participation in an event sanctioned by the American Herding Breed Association (AHBA). I agree to assume all responsibility for any claim, loss or damage, of whatever kind or nature, whether to person or property, which may be caused at or near this event, either directly or indirectly, by me or the dog or dogs I have entered in or brought to this event. I further agree that I will hold the AHBA, its officers, directors, agents and members harmless and defend them from any and all liability for any injury, claim, damage or loss, of whatever kind or nature, whether to person or property, caused at or near this event, whether directly or indirectly, by me or any dog I have entered in or brought to this event. I agree to indemnify the AHBA, its officers, directors, agents and members for any loss, cost or expense including attorney's fees and costs, to which the AHBA, its officers, directors, agents or members might be subject as a result of any claim, suit, loss or damage caused in any way by any act or negligence on my part or on the part of any dog or dogs I have entered in or brought to this event. I acknowledge that while the AHBA may provide sanctioning for this event with regard to the issuing of titles, it does not have and does not exercise control over the conduct of the event or those present. I certify and represent that the dog or dogs I have entered in or brought to this event is/are not a hazard to other dogs, other animals, or to people.

I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the Herding Test and Trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other causes.

DIRECTIONS TO THE OAKS RANCH

Via I-10 East:

1. Take **Exit 88** for **Calimesa Blvd**.
2. Turn left onto **Sandalwood Dr** and continue for **0.1 miles**.
3. Turn right onto **Calimesa Blvd** and continue for **2.3 miles**
4. Turn left onto **Cherry Valley Blvd** and continue for **3.7 miles**
5. Turn left onto **Noble St** and continue for **0.4 miles**.
6. Turn right onto **Dutton St** and continue for **1.0 mile**.
7. Turn right onto **Bellflower Ave**. The destination will be just ahead on Bellflower Ave.

Via I-10 West:

1. Take **Exit 96** for **Highland Springs Ave**.
2. Turn right onto **N Highland Springs Ave** and continue for **2.7 miles**.
3. **N Highland Springs Ave** will turn left and become **Cherry Valley Blvd**; continue for **0.4 miles**.
4. Turn right onto **Bellflower Ave** and continue for **0.4 miles**.
The destination will be ahead.
