Livestock replacement costs are as follows: Ducks \$50, Sheep - \$400.00, Cattle \$1000. Bitches in season will run last in test runs. They should be crated away from trial arenas when not competing. All dogs must be on leash when not competing. Trial committee will determine run order prior to the trial. Entry fees will only be refunded if request is received before pre-entry closing date.
